

Child marriage success story

Janseva Gramin Vikas Va Shikshan Pratisthan, Nanded and Child Line 1098 team was received information about the child marriage. The staff of Janseva Gramin Vikas Va Shikshan Pratisthan, Nanded was taken the action about the child marriage.

The girl named Maya Uttam Waghmare aged 17 years lived in Savargaon Taluka Ardhapur District Nanded we have visited the girl's home when she said that her marriage was arranged with the unknown person then this confidential information was received from the girl herself then team of Janseva Asha Suryawanshi and Nilesh Kulkarni followed up and the girl She met her parents and counselled them. She said that she did not want to do this marriage.

She told her parents that under the Prevention of Child Marriage Act, 2006, child marriage of a minor girl is an offense under the law and marriage of a girl before the age of 18 and a boy before the age of 21 is an offense under the law. A fine of one lakh rupees or imprisonment for two years can be imposed for this. Child marriage of the said girl was stopped.

Child Marriage Case Study

Child's Name: Kranti, Maharashtra

Child's age is 15 years

Kranti is a 15 year old girl studying in class 9, She did not go to school from the last eight days. We think? What was the reason, She didn't go to school? After discussion with the community she was wearing a green chuda and the wedding date was four days later. One brother and father was addict mother was He was taking care of the family alone so her mother arranged her marriage but she didn't want to get married now she begged her parents at school but they didn't listen to her she was also shoulder ring all the burdens because her father was addicted to alcohol he was drinking everywhere and her mother was doing all the preparations for the wedding. She didn't know who to ask. The girl's mother decided to help herself. She listen Janseva Gramin Vikas Va Shikshan Pratishthan was working on child marriage and she attend an awareness program in the school in which they informed that children between the age of zero to eighteen years are in any kind of trouble, they can approach the staff of Janseva Pratishthan and tell their problem like child marriage, child labor, child abuse and any other problem. If the children are facing Janseva Pratishthan helps the children to solve their problems where she got the information from the staff of Janseva Pratishthan in school she immediately contacted the staff of Janseva Pratishthan and asked for help that she doesn't want to get married she wants to complete her education As per the help requested by the girls the girl immediately The staff of Janseva Pratishthan immediately informed the police station and they also informed the child protection cell and with the help of the district women and child development office and the child protection cell they reached the police station and informed the police about everything and along with the police they reached the marriage venue and went there and informed the girl's mother. Made and asked to appear before the child welfare committee and explained to the mother how this child marriage is wrong and what are its consequences and what are the provisions of the Prevention of Child Marriage Act 2006 and what are the punishments for child marriage. The girl was also very angry. On the contrary, she asked a simple question, she said that because a girl from

our village has run away, we are afraid that she will also run away and we are doing this marriage so that nothing happens that will bring us into disrepute. If our daughter runs away, are you responsible for it? If she gives her life, if you are responsible, she explained to her that you will not give anything to the girl and nothing bad will happen to her. There was an example in the village that your daughter will act like that or run away like that. Don't Do Doubts Doubts came in your mind and you arranged the marriage of a girl but this will not make your own daughter's future bright. If she completes her education, her future will be bright and if she gets married after eighteen years, she will not have any health problems. After the age of 18, she would have understood the responsibility and she would have fully developed physically. Presently the age of the girl is fifteen years and the girl is going to school she is completing her education and her child marriage was annulled on her wedding day she is living happily now.

Also we have discuss with the CWC, DCPO, DWCD, Police Department, Police Patil Gramsevak regarding Child Marriage, Child Trafficking, Bachpan Bachao Andolan and Child Sexual abuse.

During this discussion and awareness program

The above success story about the above is presented that the girl name Sonali Datta Giri years 14. ra Margyal t. Mukher Dist. Nanded and her relatives were counseled by the order of the Child Welfare Committee after the information was received that the girl is a resident of Nanded. On top of that she was guided on the side effects of child marriage and its physical and mental consequences. After that it was recorded child marriage. In front of everyone, a guarantee letter was written from the parents of the said girl and to the complete embarrassment of the guaranteed party, the private was also taken. After 18 years of marriage, the marriage of a girl was taken in writing, after which the girl was wanted by her father. To prevent the said child marriage, Police Patil, VCPC Sign (1095) and Counselors were present.

Child marriage free success stories

Ms. Rudrakshi Vijay Jadhav is a resident of Malwada village of Mahur block in Nanded District and she is 16 years old and studying in 10th standard. The girl's parents were secretly planning her marriage. Janseva has working in this village and Shama is received this message received from one girls. Then she visited her family to verify the incident and got to know the detailed information, many things were revealed in it.

Daughter Ms. Rudrakshi Vijay Jadhav is studying in class 10 and is just 16 years old. The girl's father work as a labour. He had a heart attack, so there is a fear in his mind that if I have got another heart attack and dies, what will happen to my family behind him. So, he thought that it would be better if his daughter got married before his eyes. So, he had taken a firm decision to give his daughter for his sister's son i.e. his nephew. As his sister is also suffering from terminal illness, his last wish is to get his son married and see him happy. So, they tried to do this marriage in a secret manner. But their efforts were thwarted. The workers of Janaseva Gramin Vikas va Shikshan Pratishtan met the parents of Asha and Anganwadi worker of the village, at the right time and established a friendly relationship with them. And if a girl is married off before 18, then it is a crime according to the law, for which everyone in the family can be jailed and also have to pay a fine in the form of money. So, you gave them full information that you cannot arrange this marriage. And the eyes of that family were also opened when the girl was strictly warned not to marry unless the age of the girl was 18 years and the boy was 21 years of marriage.

In this way, this marriage conspiracy was successfully foiled. At this time, information was given to the village child protection committee

Dinesh Narwade is Umri Ba. The residents he is working as a farm labourers. His wife is a labourer. They have 4 daughters. And all girls go to school. In line with the Child Marriage Free India project of Janaseva Gramim Vikas Va Shikshan Pratisthan. Child marriage by meeting all the parents in the village, child. Guided about Balmajuri. By going to Gram Sabha, Anganwadi, School and other places in the village, they gave information about child marriage. At the same time, he met Sarpanch Mr. Narwade of the village and told him that teach the girls, they will be smart and don't rush to marry them. A lot of responsibility falls on them at a young age. It affects their physical and mental health. And doing so is an offense under the law. Imprisonment for 2 years and fine of one lakh is punishable. This complete information was given to him. And they also realized that marrying a girl before 18 years and a boy before 21 years is a big crime. So he took an oath that he would not marry our daughters. And swore not to let others do this.
